*Individuals must submit a "Request to Address City Council" form to the City Clerk prior to the start of the meeting.

Anyone may address the City Council on any issue within the jurisdiction of the Council. City Council may generally not discuss items that are not specifically identified on the agenda, except in certain circumstances. Therefore, pursuant to A.R.S. § 38-431.01 (H), action taken as a result of public comment will be limited to directing City staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date. Items on the agenda will not be heard or discussed in Call to the Public. Video or audio tapes or other overhead visual aids may not be presented during these public appearances. All speakers should begin their remarks by stating their name and address for the record.

**Any citizen of the City may appear before the Council at any regular meeting and present a written petition. Such petitions shall be considered, and response given within 31 days in conformity with the requirements of the Charter, the Open Meeting Law, and other statutory and constitutional provisions per Holbrook City Charter Article II, Section 2.18.

Unauthorized remarks from the audience, clapping, stomping of feet, yelling or any similar demonstrations are also prohibited. Violations of these rules may result in removal from the meeting. Individual members of the public body may respond to comments made by others who have addressed the public body.

The Holbrook City Council may discuss or take legal action on any item listed on the Agenda.

Pursuant to ARS 38-431.02, notice is hereby given to the Holbrook City Council, and to the general public that a meeting, which is open to the public, will be held on above-mentioned date and time, in the City Council Chambers, at 465 First Avenue, Holbrook, Arizona. CALL TO ORDER: Mayor Smith called the meeting to order at 6:00 p.m.

<u>ROLL CALL</u>: Councilmembers Robert Black, Tamera Church, Arcenia Pacheco, Karina Pack, Teri Tafoya, Vice Mayor Mike Nilsson and Mayor Kathleen Smith.

<u>CITY STAFF</u>: Assistant City Manager Randy Sullivan and City Clerk Lisa Hunt. Safety Coordinator DV Stuart in audience.

<u>PLEDGE OF ALLEGIANCE/INVOCATION</u>: The Pledge of Allegiance was led by Councilmember Church. The Invocation was given by Gloria Montoya of Day Star.

<u>CALL TO THE PUBLIC FOR NON-AGENDA ITEMS</u>: Joy Simpson, a Holbrook Citizen, shared with he Council that her water bill has gone up in price and that the toter is too heavy for her to push to the curb and she would like the City to see about getting half sized toters.

PRESENTATIONS:

a. Historical Society Report. Lois Jeffers told Council about many of the visitor that they have had that have stayed in Holbrook extra days because of how much they enjoyed the museum. Bill Parker shared several pictures of newly renovated rooms in the museum and shared a little bit of history of the Historic Society. Kudos were given to Dawn Sawyer and Sherry Reed for the work that they have done.

OLD BUSSINESS (DISCUSSION AND POSSIBLE ACTION):

a. Ordinance 25-02: 2nd Reading – An Ordinance of the City of Holbrook, Arizona, amending the Holbrook Zonine Code, Chapter 6 – Planning and Zoning, article 6-1 – Zoning Ordinance, Section 6-1-3 – Definitions, by adding the definition "Legal Parking Space" and "Mobile Vending Unit", and Article 6-2 – General Regulations, Section 6-2-2 – Parking, by adding Section 6-2-2(L) for the regulation of Mobile Vending Unit Parking; Providing for repeal of conflicting ordinances; Providing severability: and providing for penalties. – Mayor Smith read by heading. Council discussion was held.

a. Proclamation: Happy Holbrook Month – Councilmember Tafoya read the Proclamation in full.

b. Proclamation: Fair Housing Month – Assistant City Manager Randy Sullivan shared with the Council that this

Proclamation must be done to get funding through CDBG and NACOG. Mayor Smith read the Proclamation in full.

c. Special Event Liquor License – Mayor Smith reviewed the event that the Special Event Liquor License will be used for. (May 31st, Old West Fest on Route 66).

d. Swine Ordinance request – Discussion only: Mayor Smith shared that Meghan and Steven Carbonneau are in the audience to answer questions. Mayor Smith then reviewed the Ordinance that the City of Taylor has in place regarding 4H member and the zoning of Swine. The Council discussed some of the pros and cons of having an ordinance to allow 4H members to house swine in their residential neighborhoods. Mr. and Mrs. Carbonneau shared the reasons why they are asking for this. Council directed City Staff to do research and present an Ordinance at the next Council Meeting.

e. Hunt Park Elements discussion: Mayor Smith read the Background and Discussion from the City Council Action Item Request Form. Mayor Smith then reviewed the priorities from the survey summaries that were shared with the Council. Councilmember Tafoya said that she had heard from several community members that there is a need for an additional ball field at the park. Mayor Smith shared that the other priorities were for 4 to 6 Pickleball Courts, to re-do the basketball courts, increase the number of baseball fields, and lighting. Council discussion was held. Council directed City Staff to get bids for these items and bring them to the Council.

Subject: Creation of a Holbrook Graffiti Task Force

BACKGROUND AND DISCUSSION: A municipal graffiti task force is a dedicated team or program within a city or county government that works to address and combat graffiti issues. These task forces typically involve multiple city departments, like police, public works, and code enforcement, and may also include community volunteers and partnerships with local businesses. Their goals include preventing graffiti, enforcing existing laws, cleaning up graffiti, and educating the public about its negative impact.

Key Functions of a Municipal Graffiti Task Force:

Prevention:

Implementing strategies to deter graffiti, such as improved lighting, installing vandal-resistant materials, and community outreach programs.

Enforcement:

Working with law enforcement to investigate and prosecute graffiti vandals.

Removal:

Coordinating efforts to quickly and effectively remove graffiti from public and private property.

Education:

Raising public awareness about the costs and consequences of graffiti, both in terms of cleanup expenses and the overall impact on the community.

Collaboration:

Partnering with community groups, businesses, and other organizations to address graffiti issues.

Graffiti Free Phoenix



The Neighborhood Services Department is always promoting the importance of a graffiti free Phoenix. Individuals, neighborhood and corporate organizations are encouraged to join the city in keeping it blight free. Here's how you can make a difference:

- Volunteer to remove graffiti by hosting a community cleanup.
- Keep your own property free of graffiti.
- Sign up to take a free Neighborhood College workshop and learn how to use a paint sprayer to remove graffiti.

Graffiti is costly and destructive, and sends a message that the community is not concerned about the appearance of its neighborhoods. To help in the effort, the city created the Graffiti Busters Program. You can take control of your neighborhood by quickly removing graffiti. Graffiti Busters crews remove graffiti reported through various ways and also coordinate with other public and private agencies to remove graffiti. Prompt removal reduces the chance of graffiti reappearing and helps maintain a safe, secure and attractive environment.

The goals of the program:

- Support a zero tolerance approach to graffiti in our neighborhoods.
- Reduce the social and economic impact of graffiti on our neighborhoods.
- Enhance the quality of life for residents by reducing blight.
