Ordinance 25-05 – 2<sup>nd</sup> reading: An Ordinance of the City of Holbrook, Arizona, authorizing the lease of certain municipal real property to Jay Foster, and authorizing the Mayor, the City Manager, the City Clerk, and the City Attorney to execute said lease agreement and take all actions necessary to complete the transaction. -Mayor Smith read the Background and Discussion from the City Council Action Item Request Form. Co-Founder and CEO Jay Foster did a brief overview of what his company does. Co-Founder Steve Adkins and Jay Foster answered questions from the Council.

-Randy Sullivan shared that the City has been busy cutting weeds, patching roads and getting barricades ready for the Old West Fest.

-The City has also been busy getting the pool and splash pad ready for the season. The splash pad has 3 breaks so 3 of the features are not working. At the end of the season, they will fix the underground leaks and resurface the splash pad.
